## **OUR CO-OP**



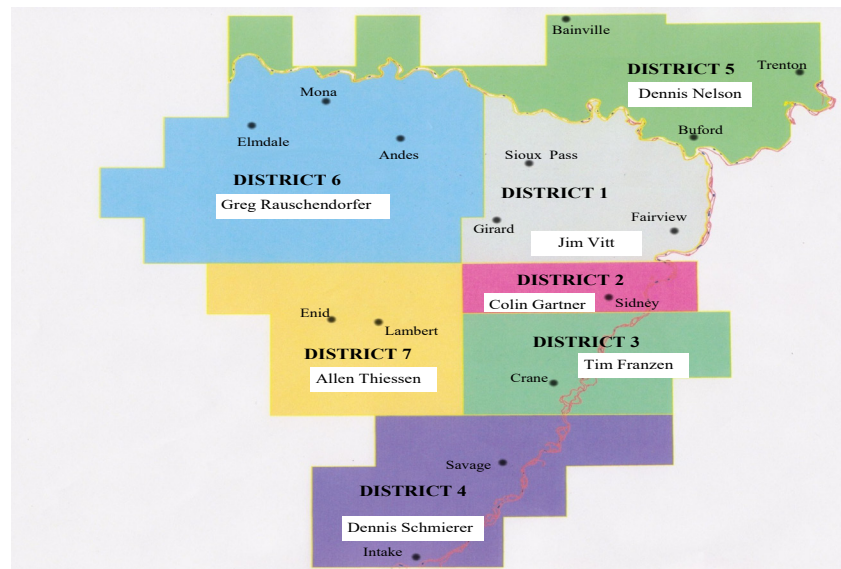
Lower Yellowstone Rural Electric Cooperative (LYREC) is a not-for-profit electric cooperative headquartered in Sidney, Montana.

LYREC delivers reliable electricity to residential and commercial members across the cooperative's five-county service district including Dawson, Richland, and Roosevelt (in Montana) and McKenzie and Williams (in North Dakota).

LYREC was the first electric cooperative to energize a line in Montana. LYREC is a distribution cooperative that receives approximately 90% of our power from Basin Electric Power Cooperative and the other 10% from Western Area Power Administration.

LYREC's directors, employees and members each play an important role in the success of the cooperative. Members elect directors and approve bylaw changes. Directors work diligently to plan for the co-op's future and assure member's concerns are continually addressed.

## **HOW WE OPERATE**



LYREC service territory is divided into seven districts and governed by LYREC's board of directors, who are elected by the membership.

Directors are elected for a term of three years. For a more detailed description on voting districts, see Article III in LYREC Bylaws.
