peration Round Up is a program made possible by the generosity and compassion of Lower Yellowstone Rural Electric Cooperative (LYREC) members. It raises funds for LOCAL nonprofit and community organizations by rounding up members' monthly energy bills to the next dollar. On average, a member donates 50 cents per month, but no more than \$11.88 a year.

In 2023, the Operation Round Up trustees granted a total of \$9,100 to these nonprofit and community organizations in LYREC's service territory:

- Senior Companion Program Gas and meals for

- · Sunrise Women's Clinic Exam chair
- Fairview Fire Department SEEK FirePro units to help identify hot spots
- East Fairview Elementary School Corps of Discovery Program
- ABATE New toys for families in need
- Rau Elementary Cement for new basketball court
- Fairview School Band trip to Denver, Colo.

Scholarship offered by co-op

ower Yellowstone Rural Electric Cooperative (LYREC) will be awarding two Basin Electric Power Cooperative scholarships for \$1,000 each to an LYREC's member dependent. The applicant must be a student who is enrolled in a full-time graduate or undergraduate course of study at an accredited, two-year or four-year college, university or vocational/technical school.

Scholarship recipients are selected based on academic record; leadership and participation in school and community activities; honors; work experience; a statement of education and career goals; and an outside appraisal. Lock your home against cyber criminals

Electric co-ops protect the private information of members and ensure hackers don't tamper with the reliability of the electric grid, but member-owners have a lot at stake, too. Think about losing all the photos on your smartphone or having bank or credit card information stolen from your computer.

TURN ON MULTIFACTOR AUTHENTICATION

Implement multifactor authentication on your accounts and make it significantly less likely you'll get hacked. This means opting into an extra step when trusted websites and applications ask you to confirm you're really who you say you are.

UPDATE YOUR SOFTWARE

Keep your security software, internet browser and operating system up to date on your mobile phones, tablets and laptops. Better yet, turn on automatic updates. When downloading a software update, make sure it's coming straight from the company that created it.

Updating your software regularly – as soon as possible when a newer version comes out – helps make sure you have critical patches and protections against security threats.

Cyber criminals all over the world are on the prowl through the internet.

Just like washing your hands to keep you from getting bacteria, there are simple things you can do to protect yourself online. Let's start with the basics of "cyber hygiene" to protect yourself online.

THINK BEFORE YOU CLICK

More than 90% of successful cyberattacks start with a phishing email.

Have you ever seen a link that looks a little off? It looks like something you've seen before, but it says you need to change or enter a password. Or maybe it asks you to verify personal information. It could be a text message or even a phone call. They may pretend to be your email service, your boss, your bank or a friend. The message may claim it needs your information, because you've been a victim of cybercrime.

A lot of the computer hacking problems result from people clicking on links or attached files that infect their computers or mobile devices. An email can even be disguised to look like it's coming from your best friend, so simple diligence can be extremely beneficial.

If it's a link you don't recognize, trust your instincts and think before you click.

Rural Development Finance Corporation awards grant

wer Yellowstone Rural Electric Cooperative is a member of the Rural Development Finance Corporation (RDFC). As a result, communities in our service area are eligible to apply for a grant of up to \$3,000 for community-based projects.

RDFC recently granted \$1,000 to the Sidney Area Chamber of Commerce and Agriculture for the Ag in the Classroom initiative, which is an education event for fourth-grade students and is offered to all students in Richland County and the surrounding areas.

The outcome of Ag in the Classroom includes an increase in the ability to understand and communicate the source and value of agriculture as it affects our quality of life. An example of Ag in the Classroom curriculum includes creating a meal completely sourced from local producers, basic emergency preparedness skills and survival tactics, and bee pollination cycles.

Need assistance heating your home this winter?

The Low Income Home Energy Assistance Program (LIHEAP) of Montana and North Dakota are accepting applications. These programs assist residents with their heating bills through the winter months.

Eligibility is based on your household income and resources. If you live in Montana and need help paying your heating bill, you can contact Energy Share at 800-227-0703. If you live in North Dakota, you can contact Community Action at 701-572-8191. You may also download an application at www.lyrec.coop or call Lower Yellowstone Rural Electric Cooperative.

The application process can take up to two months before receiving assistance. If you fall within the guidelines below and need assistance, please download an application today.

If you do not fall within these guidelines, you may still qualify for Energy Share. Energy Share benefits are a one-time grant to alleviate a temporary heating emergency. Eligibility is not based solely on income, but also on extenuating circumstances the household is facing. \blacksquare
