## Small change changes lives

The Lower Yellowstone Rural Electric Trust's Operation Round Up (ORU) started in 2017 and has raised approximately \$11,000 a year in support of a variety of charitable, educational, community and youth-related programs and events. The concept behind the program is to extend the principle on which electric cooperatives were built over 80 years ago – neighbors helping neighbors. As a Touchstone Energy<sup>®</sup> Cooperative, we follow one of the core principles, which is concern for community. ORU has granted over \$30,000 to nonprofit and community organizations in our communities.

In September, a \$1,699 grant was awarded to Savage Sunrise Manor for the purchase of a new fridge. Savage Sunrise Manor is an eight-bed assisted living facility in Savage, Mont.

The ORU board also granted \$1,200 to Crimestoppers of Richland County. In 2012, a group of Richland County residents concerned for the safety of our community restarted Crimestoppers, which was originally started in the 1980s. The grant will go toward the cost of software that enables the communication between members and law enforcement to remain anonymous. The Operation Round Up program is possible due to our members' generosity. Each month, their bill gets "rounded up" to the nearest dollar. The maximum amount any member can donate per year is \$11.88. ■

## Scholarship opportunities offered

wer Yellowstone Rural Electric Cooperative (LYREC) is accepting applications for the Basin Electric Power Cooperative (BEPC) scholarship and the Montana Electric Cooperatives' Association (MECA) memorial scholarship. All applications must be submitted to: LYREC, Attn: Jami Propp, P.O. Box 1047, Sidney, MT 59270 by the due dates listed below.

### Basin Electric Power Cooperative scholarship

Basin Electric Power Cooperative is offering a \$1,000 scholarship to an LYREC member's dependent. The applicant must be a student who is enrolled or planning to enroll in a full-time graduate or undergraduate course of study at an accredited, twoyear or four-year college, university or vocational/ technical school.

Scholarship recipients are selected based on academic record, leadership and participation in school and community activities, honors, work experience, a statement of education and career goals, and an outside appraisal. To apply, complete the required criteria and the scholarship application, which can be obtained at www.lyrec.coop. The application is due Feb. 15.

### **MECA** memorial scholarship

MECA is offering a \$500 scholarship to one eligible student from the Northeast District of Montana. The applicant's parent/guardian must be an LYREC member and the applicant must be attending college in the fall of 2021. Applications are judged on academic strength, school and community activities, employment, volunteerism, community service and personal statement.

A committee comprised of LYREC staff will choose one application to send to MECA for a chance to win a \$500 scholarship. The applicant chosen by the LYREC scholarship committee will be awarded a \$500 scholarship from LYREC.

## Rural Development Finance Corporation awards grant in Lower Yellowstone's service area

Cooperative (LYREC) is a member of the Rural Development Finance Corporation (RDFC). As a result, communities in our service area were eligible to apply for a grant of up to \$2,000 for community-based projects. RDFC is making these funds available so more people become aware of its larger loan program that funds community-based projects and nonprofit entities with lowinterest loans.

RDFC has recently granted \$2,000 to the East Fairview School. The vision of East Fairview School is to create a safe and effective environment which encourages a growth mindset and engages students in the learning process to prepare them for future success with the understanding that failure is part of the process. The grant will be used to help purchase new COVID-19 health and safety equipment such as new water bottle filler kits, air purifiers and disinfecting foggers. ■
